COVID-19 EMERGENCY RESPONSE: BACKGROUND, APPROACH & BEST PRACTICES

Background:

The recent outbreak of Coronavirus caused massive catastrophe in 192+ countries across the world. The World Health Organization (WHO) has already declared Emergency throughout the world and followed by emergency declaration in Pakistan by the government. In this context, a National Plan is being enforced immediately to cater Pandemic COVID-19. Response through lockdown has been varying including Gilgit-Baltistan and AJK. Sindh has been the first one to impose lockdown across the province that has been implemented as per SoPs,

Consequently, considering the situation, the worthy Board Members of SRSO immediately called an extra-ordinary meeting on 24th March 2020, via Tele Conference to discuss the risks and devise mitigation strategy, and Board decided that SRSO should contribute to extend its support the poor of Sindh through the organized communities in its target districts, and in this regard allocated substantial budget for the support in this testing times without jeopardizing the safety of the employees, organized communities and the general public, thus giving a helping hand to the Government of Sindh.

SRSO Approach To Emergency Response:

Sindh Rural Support Organization (SRSO) initiated the Emergency Response in the context of the COVID-19 through Community Institutions (CIs). These CIs have been organized by SRSO that have been supporting to deserving persons and households in many kinds. They have been utilizing their savings, skills, assets, and linkages to provide relief services during and after lockdown situation. The tremendous potential and resilience of CIs have contributed to relief services as the organized entity for prevention of the spread of coronavirus and enabling deserving persons to access relief services in pandemic situation. In the wake of the situation arising out of the spread of Coronavirus (COVID-19), Community Institutions have responded to the COVID-19 situation with the following initiatives.

- Community awareness campaigns for mass awareness raising.
- Ration distribution among poorer HHs.
- Utilization of community savings by Community Institutions (CIs).
- Relief assistance through Field Farmers Schools (FFAs) and Business Development Groups (BDGs) .
- Volunteer Services at UC level through Relief Committees and facilitation role in EHSAAAS Emergency Cash Program for ensuring social distancing and transparent way of cash delivery to the Beneficiaries.
- Awareness Raising of community members against COVID-19 with support of

- Distribution of pre-cautionary items i.e. Soaps, Face Masks and Sanitizers.
- Support to local authorities in Govt. health facilities and quarantines centers.



SRSO Key Best Practices and Learnings -COVID-19 Emergency Response:

- Community based institutions have played their altruistic role to support the rural society in the context of the COVID-19 pertaining to the dissemination of knowledge on Precautionary measures and provision of ration to most needy one. Rural the population has largely affected on account of the economic impact caused by COVID-19.
- Social mobilization process organized rural masses into organized structures that supported organized communities' members to help each other in times of disasters. Well placed intercommunity coordination minimized communication gaps that supported a well-organized relief response during COVID-19.
- Community Leaders, activists mobilized community-based resources, knowledge, assets and linkages at local level authorities to enable the poor to access the relief services.
- SRSO as the RSP is on board with National Command and Control Authority, Government of Sindh, District, Tehsil and UC level as key stakeholder for mobilizing communities around COVID-19 with regard to the awareness-raising on Precautionary measures, provision of food items and dissemination IEC material and protective material such as masks, sanitizers, soaps, and hand gloves.
- Business Development Groups (BDGs), Field Farmers Schools and Kitchen Gardening initiatives enabled CIs to support their community members in an emergency through utilization of their assets and profits.
- Proclaimed and appreciated the role and work of the community institutions in COVID-19 emergency response at district, provincial and national levels.





COVID-19 EMERGENCY RESPONSE: OVERALL INTERVENTIONS & ACHIEVEMENTS

A. RATION DISTRIBUTION:

17,164 poor households (HHs) were provided with ration and cash grants. 1,072 households received Cash Grant and 16,092 households received Ration Bags

B. COMMUNITY AWARENESS CAMPAIGNS:

30,795 community awareness campaigns were conducted on COVID-19 through **1,820 community volunteers** (community leaders, CRPs, etc.) and **14,073 community institutions** (COs, VOs and LSOs) engaged on public awareness campaigns.

C. THE SOCIAL-DISTANCING:

863 Social-Distancing sessions aiming at behavioral changes were conducted at community level in which **10,647 community members** participated and were made aware in SRSO 14 out-reach districts.

D. PRE-CAUTIONARY ITEMS DISTRIBUTION:

21,084 Pre-cautionary Items were distributed among the poor HHs of the targeted communities including 15,708 facemasks, 3,770 soaps, and 1,576 sanitizers.

E. REGISTRATION UNDER EHSAAAS CASH PROGRAMME:

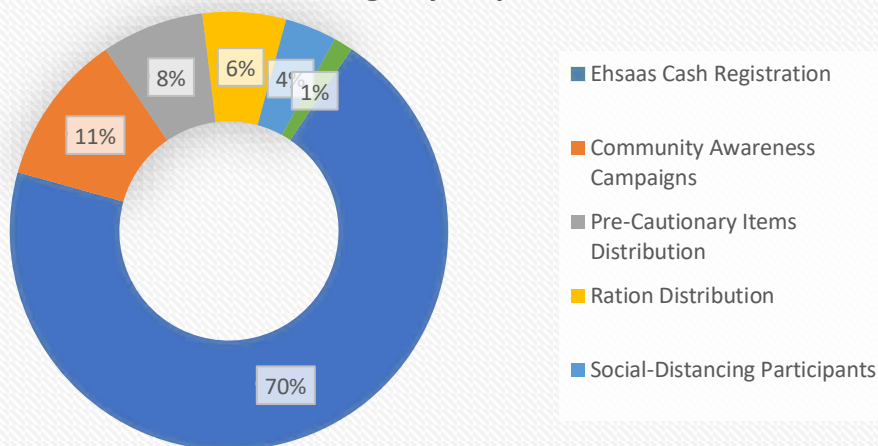
194,824 potential beneficiaries were registered under EHSAAAS Emergency Cash Programme-Govt. of Pakistan in SRSO operational areas by 4,671 community institutions (CIs) and CRPs in SRSO 14 out-reach districts of Sindh.

F. SUPPORT TO GOVT. HEALTH FACILITIES:

3,940 items were provided to Govt. Health Facilities, local authorities set up four quarantine centers, and one private medical center was supported through the provision of cooked food, surgical masks, sanitizers, and soaps.



SRSO-CVOID-19 Emergency Response Till June 30, 2020



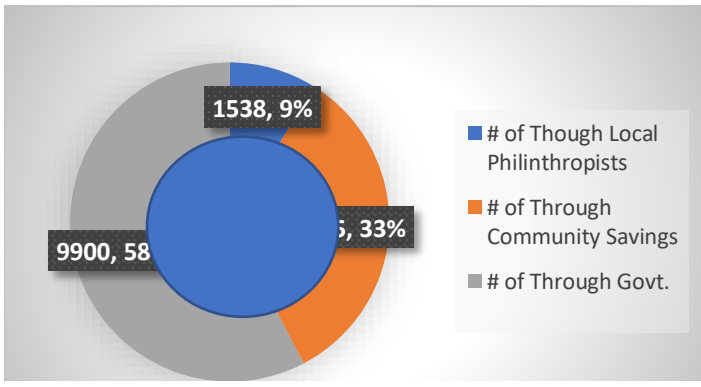


A. RATION DISTRIBUTION AMONG POOR HHs TO COMBAT WITH COVID-19 EMERGENCY



The current pandemic COVID-19 has affected severally all segments of the society especially poor households that remains vulnerable and the food is unavoidable need of poor during critical times like pandemics and disasters. Government and other stakeholders needed to fulfill this basic need of the community during COVID-19 emergency. The organized communities have formed community institutions (COs, VO's & LSOs) in order to initiate the community development process on a self-help basis and in the current COVID-19 pandemic situation these CIs Have played a vital role in addressing emergency through support to most poor households (HHs) and vulnerable communities at their own level. They have utilized their local resources and mobilized linkages with govt. departments, local philanthropists, and other stakeholders.

Sindh Rural Support Organization (SRSO) is supporting poor HHs in accessing food in the out-reach districts. According to SRSO-Cumulative achievements till June30, 2020, total **17,163** Poor Households (HHs) were supported in **distribution ration** in which provided **Cash Grant 1,072** and **Ration Bags 16,091** through community savings, local philanthropists, and Govt. support.

B. COMMUNITY AWARENESS CAMPAIGNS ORGANIZED BY COMMUNITY INSTITUTIONS (CIs)

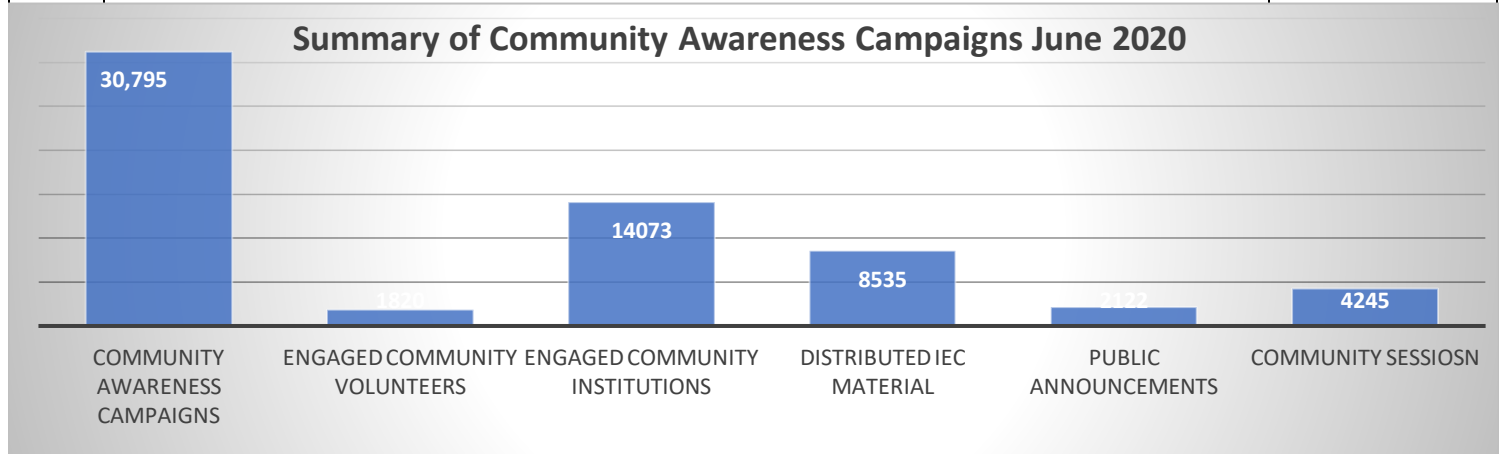
The community awareness campaigns have been initiated under COVID-19 Emergency Response by SRSO and Community Institutions (CIs) to make aware communities well aware about COVID-19 to undertake preventing measures for combating with the pandemic in an effective manner. Under these campaigns different types of interventions i.e.; community sessions, hand-washing activity, IEC material dissemination, and public announcements were planned and initiated by SRSO Teams and community institutions (CIs) at different levels especially in targeted communities of the SRSO out-reach areas of 14 districts in Sindh.

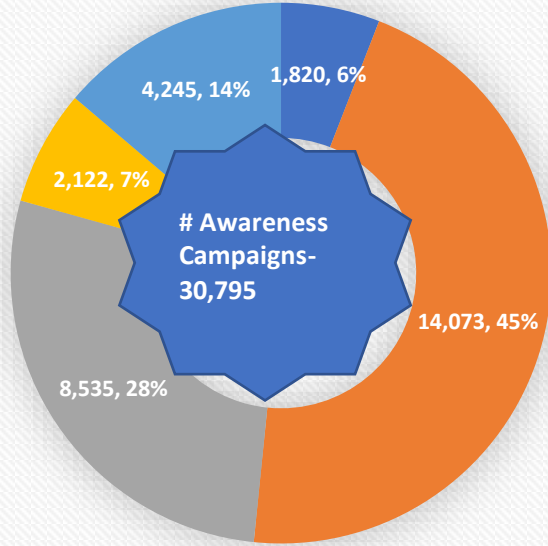
30,795 Community awareness campaigns: 8,535 items of IEC material were distributed, **1,736** announcements were made using mobile speakers, **386** announcements made using local mosques/ churches/ mandirs/, and **4,245** community sessions were organized from January to June 30, 2020 through **1,820 community volunteers** (community leaders, CRPs, etc.) and **14,073 community institutions** (COs, VOs and LSOs) support and engagement.

COMMUNITY-LED-FOOD DRIVE

Farmer Field School is combating with COVID-19 Emergency 2020

During COVID 19 Situation Farmer Field School (FFS) has played a pivotal role for supplying fresh vegetables to villagers. When lockdown was announced and people were confined at home/village, they faced hardship in purchasing food on daily basis from cities especially vegetables. The members of FFS were aware about it and they purchased fresh vegetables from Agriculture Entrepreneurs (AEs) that were made available to them economically and free of cost to poorest families. **656 Farmer Field Schools (FFSs)** have been established in three districts (Larkana 221, Kamber-Shahdadkot 214, and Shikarpur 194) under European Union (EU) supported Programme for Improved Nutrition in Sindh (PINS) and developed Demo Plots as well. These demo plots have played very important role in the fulfilment of food and nutrition needs of FFSs member and poor families of the area.

2,606 poor Households (HHs) have been supported till May, 2020 through distribution of fresh vegetables supported by these developed demo plots by Agriculture Entrepreneurs (AEs) of Farmer Field Schools (FFSs) and demo plots that benefited in 3 districts i.e. Larkana 1136 HHs, Kamber-Shahdadkot 382 HHs, and Shikarpur 1088 HHs respectively.



Business Development Groups (BDGs) formed under PPRP-Govt. of Sindh -Relief Work

C. THE SOCIAL-DISTANCING SESSIONS AIMING FOR BEHAVIORAL CHANGE

Sessions on social distancing were conducted with community members under the objective to bring about change in behavior and adapt prevention measures regarding COVID-19. The community institutions (COs/VOs/LSOs) and SRSO teams conducted awareness Session during the regular meetings, sessions, and field visits. SRSO team and community members followed SoPs of social distancing during their daily /routine professional and personal lives.

863 Social-Distancing Sessions aiming at behavioral changes were conducted till June 30, 2002 at the community level in which **10,647 community members** participated and made aware about COVID-19 and the importance of social-distancing.

D. PRE-CAUTIONARY ITEMS DISTRIBUTION AMONG COMMUNITIES FOR COMBATING WITH COVID-19 EMERGENCY

The pre-cautionary items/ Personal Protective Equipment (PPEs) distribution is an important response in the targeted communities of SRSO-outreach districts in order to strengthen prevention measures during the COVID-19 emergency. In this regards, different precautionary items/PPEs i.e. face masks, soaps, gloves and sanitizers were distributed among communities, program beneficiaries and other stakeholders with the support of the community institutions (CIs), business development groups (BDGs), and local philanthropists to support them in adapting preventing measures against COVID-19 pandemic.

21,084, pre-cautionary Items/PPEs have been distributed till June 30, 2020 among the communities including **15,738 facemasks**, **3,770 soaps**, and **1,576 sanitizers** through community savings, local philanthropists, and government support.

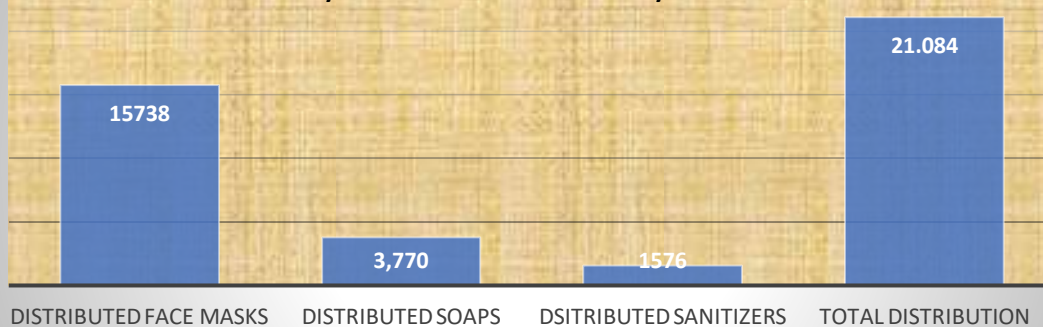

Community Institutions-Led Emergency Response

Role of Community Institutions (CIs) and Volunteers in COVID-19 Emergency Response

COVID-19 emergency has emerged importance role of community institutions and volunteers in the response. They have also played active role and take responsibility as well and their role has been appreciated and proclaimed by community, civil society, media, and government. The CIs and Volunteers have played their role in the community awareness campaigns, mobilizing local resources for ration distribution information and registration process of potential community members in EHSAAAS Cash Programme-GoP, managing EHSAS Cash Centers and Relief Committees-GoS

- **30,795 Community awareness campaigns** on COVID -19 through **1,820 community volunteers** (community leaders, CRPs, etc.) and **14, 073 community institutions** (COs, VOs and LSOs) engaged in public awareness campaigns.
- **4,617 community institutions (CIs)** village Organizations (VOs) 4,132 and Local Support Organizations (LSOs) 485 in 495 Union Councils played actively role in the registration process of **194,863 potential beneficiaries** of EHSAAAS Cash Programme-GoP.
- **348 special; committees** with active members of LSOs, VOs and CRPs activists were of these Relief Committees at District, Taluka and UC Levels. These committees worked in **459 UCs of 64 Taluka and 14 districts of Sindh.**
- **350 poor Households (HHs)** were have been supported through distribution fresh vegetables, which produced at developed demo plots, by agriculture pressures of Farmer Field Schools in three districts. Larkana 200 HHs, Kamber-Shahdadkot 120 HHs and Shikarpur 100 HHs
- **Business Development Groups (BDGs)** formed under People’s Poverty Reduction Programme-Govt. of Sindh have provided to relief services through their established business like; provision fresh vegetables of tunnel farming, support in floor machines, livestock etc.





E. EHSAA S CASH REGISTRATION PROGRAMME

4,617 community institutions (CIs) village Organizations (VOs) 4,132 and Local Support Organizations (LSOs) 485 in 495 Union Councils of 14 out-reach districts of SRSO played an active role in the registration process of **194,863 potential beneficiaries** of the EHSAA S Cash Programme –Govt. of Pakistan. The role of CIs in the registration and cash transfer process is as under;

- The community members were informed about EHSAA S Programme and facilitated into registration process through door to door visit
- On the request of district administration, community institutions (CIs) managed EHSAA S Cash Centers and ensured social-distancing, handwashing, and other SOPs at centers
- CIs arranged hand-washing corners and ensured soaps, sanitizers, and drinking water facilities or beneficiaries, cash transfers centers, staff, and visitors.
- CIs also conducted awareness sessions, made aware, and sensitized the people on COVID-19 and its preventing measures.
- These efforts of CIs were widely appreciated by community members, media, and district administration at large.

IEC Material Development & Dissemination under Community Awareness Campaigns

The Information, Education & Communication (IEC) material dissemination was another important initiative under Community Awareness Campaigns to combat COVID-19 emergency. In this regard, Sindh Rural Support Organization (SRSO) developed, designed and printed IEC material i.e. Pena flex, standees and posters in initial days of the lockdown and displayed at prominent public places, offices and disseminated at large and used it as resource material during the meetings, sessions, and other activities.

SRSO signed MoUs with 10 district administrations under National Control and Operation Center (NCOC), Govt. of Pakistan agreement regarding social mobilization and awareness on COVID-19. IEC material was also received from district health department and disseminated among the communities under this agreement.

According to SRSO's Cumulative-Data-Base **8,535 IEC material/items** have been distributed in the communities till June 30, 2020 in all SRSO 14 out-reach districts of Sindh.





F.SUPPORT GOVERNMENT HEALTH FACILITIES

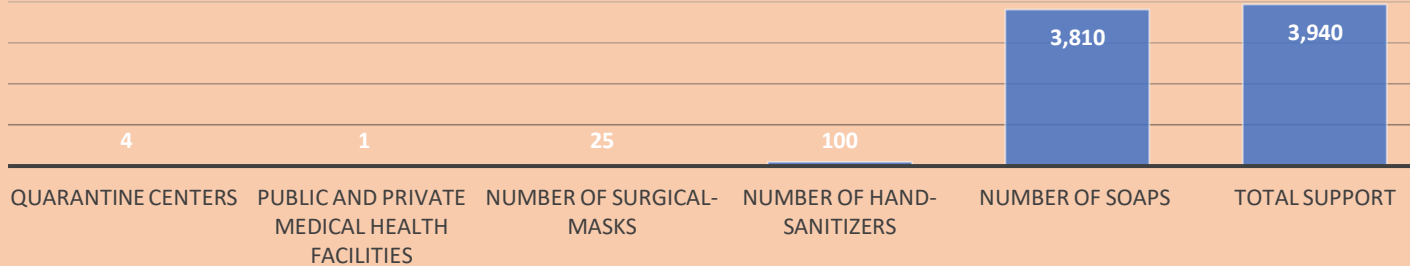
Rural Support Organization (SRSO) is supporting emergency response at different levels and means in order to provide relief services to poor HHs and strengthening Govt. initiatives as well. In this regards, SRSO supported medical health facilitated and established quarantines centers at Sukkur, Larkana, Ghotki, Shikarpur, and Jacobabad through provision PPEs.

3,940 PPEs items were provided to Govt. Health Facilities included four quarantine centers set up by local authorities and one facility of medical center was provided and supported through provision of cooked food, surgical masks, sanitizers, and soaps to combat COVID-19 Emergency.

Community Mobilization and Awareness Raising on COVID-19 under NCOC Agreement

A Memorandum of Understanding (MoU) was signed by SRSO with 10 District Administrations under National Command and Control Center (NCOC) Agreement regarding Community Mobilization and Awareness Raising on COVID-19. In this regard, different activities were started from May, 2020 in order to mobilize and aware communities through conducting awareness sessions and dissemination of IEC material provided by health department/district administration in 10 outreach districts (Larkana, Kamber-Shahdadkot, Shikarpur, Jacobabad, Kashmore @ Kandhkot, Khairpur, Sanghar, Mirpurkhas., Badin, & Thatta). Orientation/training sessions of Community Institutions' representatives on COVID-19 were also conducted with the support of the District Health Department, and handed-over IEC material. The trained/oriented CIs representatives conducted the community-based awareness sessions on social distancing, handwashing activity disseminated and displayed IEC material as well in their areas.





G. ROLE OF COMMUNITY INSTITUTIONS IN RELIEF COMMITTEES-GOVT. OF SINDH

Government of Sindh formed the Relief Committees in order to provide relief especially ration to most vulnerable families during the lockdown at District, Taluka, and UC level. The notification was issued by Govt. of Sindh and nominated representatives of community institutions as a member, and engaged them into the identification and distribution of ration. Deputy Commissioners, Assistant Commissioners, and UC Chairmen following their domain chaired these committees.

348 special committees with active memberships of LSOs, VOs, and CRPs activists were formed Relief Committees at District, Taluka, and UC Levels. These committees worked in **459 UCs of 64 Taluka and 14 districts of Sindh.**

Case studies on community leaders' work

Case 2: Ms Pathani, LSO Shah Latif, UC Balouchabad, District Mirpurkhas, Sindh

Training: Ms Pathani received training on Combating COVID-19 on 19th June organised by SRSO and district health department.

Activities: Delivered awareness sessions to 152 women of 9 villages, on health/ hygiene and COVID-19 preventive measures, and also distributed IEC material and soaps.

Community response: Communities are appreciating the support of district health dept., and following SOPs.

Challenges: Travel in public transport is risky as well as expensive, people are becoming less careful about preventive measures after lifting lockdown by the government.



Case studies on community leaders' work

Case 1: Ms Abida, Treasurer LSO Roshan Deeo, District Kamber Shahdaddkot, Sindh

Training: Ms Abida received the training on community mobilisation component of TTQ from SRSO.

Activities

- Conducts awareness sessions on COVID-19 at community and household level;
- Distributed 50 face-masks in two villages;
- Supported 150 needy households with food rations;
- Assisted 291 poor households to register with Ehsaas programme;

Community response: Awareness levels on COVID-19 and preventive measures in communities is now enhanced. Communities are now practicing all the critical precautionary measures in their daily life.

Challenges: Demand for face-masks & soaps has now increased and some mechanism needs to be established to make these available for poor and poorest households.

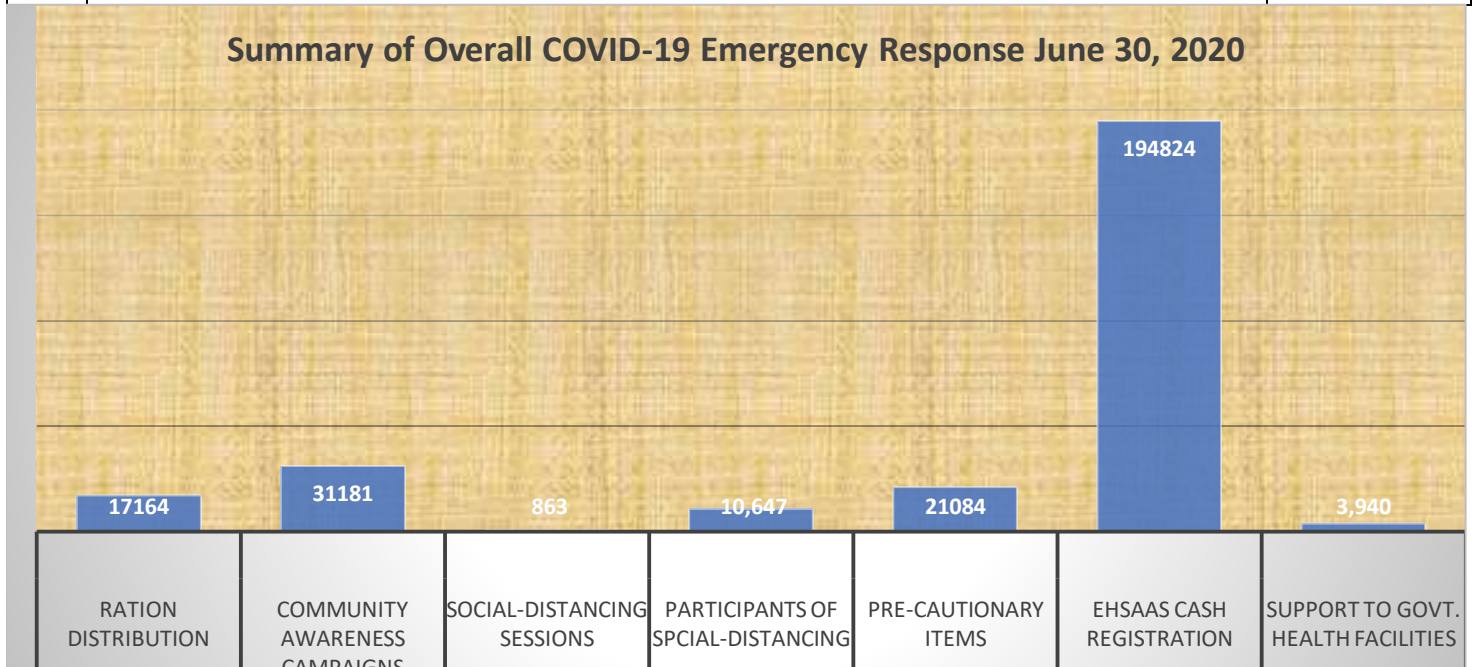
